ANCHO is a housing association based primarily in Irvine, Ayrshire. We are a registered social landlord and a registered charity. We own and manage almost 700 houses and 250 lock-up garages and provide factoring services to over 200 owner occupiers. Our turnover is over £2.6m.



Our story

Our aim is to create neighbourhoods where people want to live. We do this through providing excellent services to our tenants and customers; investing in the houses we own; working closely with local communities to meet their needs and focusing always on our role as Community Anchors within those communities.

Being a Member of the Management Board of ANCHO is an important responsibility but it is also an interesting and learning experience The Management Board ensures that ANCHO operates within the law, operates according to its Rules, Membership Policy, Standing Orders, policies and procedures and meets the standards laid down by the Scottish Housing Regulator and other regulatory bodies. They establish our business and financial strategy and objectives, and their first duty is to our tenants, applicants and other service users. They also set targets and monitor performance of staff against them.
